Current Status

- ► ISO 17011 allows surveillance assessments, w/ full reassessment every 5 years (must do site visit every 2 years, per 7.11.3 b)
- ► V2M1 of TNI ELSS states same, but V2M3 requires full reassessment every 2±½ yrs



Progress to Date

Original ABTF recommended "Form a Task Force with representatives from Accreditation Body Committee, Onsite Committee and LASEC to investigate how surveillance assessments could be implemented...."



First Response – Joint Workgroup of LAB and LAS Committee

- Conclusion: Changing to 5 year cycle w/ surveillance in between will not ease resource demands on NELAP ABs
- Maybe resource savings for VLL*, but greater use of resources for small labs
- Many more small labs in NELAP

*VLL=very large lab



Unresolved....

- Substantial time savings estimated for VLL (322.5 vs 270 staff hrs) – pushback from stakeholders
- Similar time (1/2 day) each visit PLUS an additional visit/assessment cycle for small labs.
- Some ABs and others WANT 5 YEAR CYCLE



Response of TNI Board at January 2012 Meeting

 ABTF recommended referral to LAB Expert Committee for consultation w/ stakeholders, to resolve differing opinions



LAB EC Consultation with NELAP AC

- Discussion included
 - understanding potential difficulties in travel (only if required by regulation)
 - potentially higher resource costs for additional travel that would likely be incurred by NELAP ABs (for small labs)
- Consensus changing the standard is undesirable at this time
